PRICES

FAIR AND TRANSPARENT PRICING

- We don't keep our prices a secret! We always aim to charge very competitive fees for the area.
- We will work with you to get the maximum allowed Government funding
- Our fees are inclusive of all food and drinks. Cows' milk and formula milk are also provided
- Fees are calculated as 52 weeks divided into 12 equal monthly payments, with holidays charged at the normal rate. Fees are payable one month in advance, by direct debit, bank transfer, 'tax-free childcare' account or childcare vouchers, before the 1st of each month.

Discounts

We offer a 10% sibling discount, in the form of 10% off the eldest child's monthly fees.

Full time, 5 days per week attracts a 5% discount, included in the table below.

- **Booking Patterns**

The minimum booking is 2 days per week for children under 3, and 3 days per week for over 3's.

We require written notice, one month in advance, should you need to change your booking pattern.

Requests for extended hours require one week's notice.

Changes to booking patterns are subject to availability, but we will always work with you to fit your needs the best we can.

- **Additional Fees**

Individual extra days are charged at £83 Age 2 and above, £87 under 2.

Early Start (7:30 to 8am) and Late Finish (6pm to 6:30) charged at £5 each, only if booked in advance.

We charge a flat fee of £100 to cover the cost of externally provided entertainment and classes (for example animal visits, ballet, music workshops) and resources, nappies, wipes and creams, this is reflected on the invoice as 'Non-Food Consumables'.

- **Registration and Deposits**

A non-refundable registration fee of £50 is required to register with us together with a deposit of £200 per child. The deposit is refundable once we have received 1 month's written notice of intent to leave and is returned when your child leaves.

In the case of withdrawals without notice, the deposit will not be refundable.

Should we be unable to place your child due to lack of capacity, your deposit will be held and your child will be placed on a waiting list, or you may choose to have your deposit returned. We aim to contact you at least two months before your desired start date.

- **Guaranteed Spaces**

We are sometimes able to guarantee a place in return for a non-refundable payment of a month's fees if we expect to have a space at your chosen date, please contact us for availability.





WAYS TO SAVE ON FEES

- **Childcare Vouchers** - these are offered by employers and are deducted from gross pay (before tax)
- **Salary Sacrifice** – If your employer has a Salary Sacrifice Scheme we may be able to register you as a Workplace Nursery using our partner, Enjoy Benefits
- **Tax-Free Childcare** - this is a government scheme that contributes £2 for every £8 a parent puts into their childcare account, which is then paid to a provider
- **Funding for Under 3's** – Eligible parents will receive means tested 15 hours funding for children over 9m, extending to 30 hours in September 2025. If your circumstances mean that we are unable to claim then the unfunded fees apply.
- **15 Hours Universal funded childcare** – Parents that don't qualify for means tested funding automatically get 15 hours funding from the term after the third birthday.

Both 15 and 30 hour grant entitlements are sent to us directly from Croydon Council and cover 38 weeks. The grants are spread over 52 weeks in our billing system to give you consistent invoices.
